...all so that #StartupGVL continues to be the top ecosystem in South Carolina and one of the most attractive across the Southeast.







**SEARCHERS** 

The very earliest stages of business creation. Not yet legally formed as an entity and may not have developed an MVP (minimum viable product). They're likely armed with a pitch deck and a dream.

**STARTERS** 

These are founders who've started their engines. They've got a legally formed entity, likely post-revenue and/or have produced a prototype or MVP. Could be experiencing 50% growth year-over-year.

**MOVERS** Now things are taking off and leaving the runway. It's a transient stage as their business is poised for growth, but hasn't hit certain markers yet (often a "growing pains" stage) as they try to scale.

**GROWERS** Growers are fully in flight. They're experiencing 100% growth year-over-year, they've got full-time, salaried employees (including themselves!) on the books and likely actively seeking/have received investments.

It's important to not just talk about the NEXT generation of founders, but also to shine light on the founders who have been here from the start and are now giving back through their mentorship.

#### **Boyd Cycling** - Grower



Team/Headcount: 12, all local

Programs: VMS (mentee & mentor), CEO Lunch, 2023 10 Most Exciting Startup

Boyd Cycling has come full circle, or should we say wheel, in the NEXT family. The Boyd Cycling team, **Nicole and Boyd Johnson**, joined NEXT in the early years and have been active in the VMS Mentor Program & CEO Lunches. Fifteen years later, co-founder Nicole is pouring back into the very same programs as a new mentor and NEXT board member while leading the second iteration of CEO lunches. Initially, there were doubts (gasp!) about whether Boyd aligned with NEXT's client profile focused mostly on tech. However, companies like Boyd Cycling, driving growth, scaling, and transforming their industry from within, have proven you don't have to be a tech company to scale OR to be a valuable asset to the NEXT programs.

#### Kopis - Grower

Team/Headcount: 66, 51 local Programs: VMS (mentee & mentor), CEO Lunch

Kopis, an early player in the software development industry, showcased commitment by opening an office in the NEXT Innovation Center and engaging with the Venture Mentoring Service (VMS) Program. Founded by **Andy Kurtz**, Kopis is a significant resource in software development and actively gives back through mentorship in the VMS Program. This highlights the crucial role of successful founders in fostering growth in the startup community. The philosophy of contributing to emerging entrepreneurs underscores Kopis' dedication to collaboration, shared learning, and innovation, setting an example for other companies in the startup landscape.



#### Kanga Coolers - Grower



Team/Headcount: 43, 20 local

Programs: VMS

Kanga Coolers came to fame when featured on <u>Shark Tank</u> season 10 in 2019 and they've recently risen in notoriety after a featured ad on Mr. Beast's YouTube channel. Their signature product is the Kase Mate which wraps around a cold case of your favorite beverage but they've diversified their products with different sizes as well as a bookbag cooler. With a team of over 40, this college dream of founder **Logan LaMance** and his cofounders has turned itself into a multi-million dollar company with lots of hard work, great mentorship, and a little bit of luck never hurts!

# WE HELP TELL THEIR STORIES.

#### **Zylö Therapeutics** - Mover

Team/Headcount: 10, 8 local Programs: CEO Lunch, Match Day

Zylö Therapeutics founder **Scott Pancoast** joined NEXT in 2018 so they're not new on the scene, but like many startups, they're seeing a real breakthrough years after they started. Whereas some startups achieve fast and early growth, for many founders, it takes years of grinding away to achieve some "success." Scott's journey has been one of ups and downs but his commitment is unwavering. He recently exemplified his grit by personally delivering their largest order to Minneapolis, MN - four barrels in a rented truck -an 18-hour drive! Scott continues to engage with and support the ecosystem, especially when it comes to deciphering SC Angel tax credits. Keep an eye on Zylö - we see big things in their future.







Team/Headcount: 9, 5 local Programs: Accelerator, VMS

Rebel Rabbit's guiding principle is simple: "You do you." Cofounders **Pierce Wylie and Billy Goldsmith**'s rebellious, cannabis-infused seltzer is swiftly gaining popularity nationwide. Rebel Rabbit extracts the legal D9 THC compound from the cannabis plant and integrates it into an all-natural blend. Having recently acquired the old Brewery 85 space in Greenville as part of their second company, Upstate Beverage Consultants, LLC, Rebel Rabbit directly sells its products to consumers and also distributes widely. Achieving remarkable growth since its inception in 2021, the company is on track to earn its third million. Operating in a relatively new industry, the team faces unique challenges, but provides valuable insights to fellow founders in the adult beverage sector as well as through their NEXT Accelerator cohort.

#### skillsgapp - Mover

Team/Headcount: 8, 3 local Programs: Accelerator, VMS, 2023 10 Most Exciting Startups

Tina Zwolinski, co-founder of skillsgapp, focused on economic development, workforce issues, and marketing to youth for years. Confronted with the challenges faced by her own son navigating the educational and career landscape, Tina knew there had to be a better way. skillsgapp, launched to address the shortcomings of traditional pathways, is more than just a platform; it's a gamified experience. The platform's virtual environment mirrors real-world jobs, providing an engaging space for students to explore industries, understand job requirements, and make informed career decisions. Navigating the complexities of the education and employment landscape isn't without its challenges. skillsgapp faces hurdles common to startups, including speed to market, talent acquisition, and shifting industry mindsets. Tina draws guidance from her VMS mentors and the Accelerator cohort. "The networks formed within these programs have become invaluable resources, offering diverse perspectives and expertise that contribute to skillsgapp's ongoing growth."



#### **Performance Enhanced Delivery** - Starter



Team/Headcount: 1 local Programs: Accelerator, VMS

**Rich Johnston**, founder of GrowScripts & Performance Enhanced Delivery, created a unique slow-release coating for fertilizers, cutting field time/labor costs, and reducing environmental impact. While developing this, Rich and his wife researched the best places for business and family, choosing the Upstate over Raleigh for its entrepreneurial community. They moved to Greer in just 2 weeks! Now, as Rich navigates agriculture and product development, the NEXT Venture Mentoring Service (VMS) program provides essential mentorship and community support.



The NEXT journey has been full of trailblazing, resilience, and community spirit, but if we're not moving forward, we're not fulfilling our purpose. Imagine a future focused on growth, where connections spark creativity and where every entrepreneur finds their tribe.
